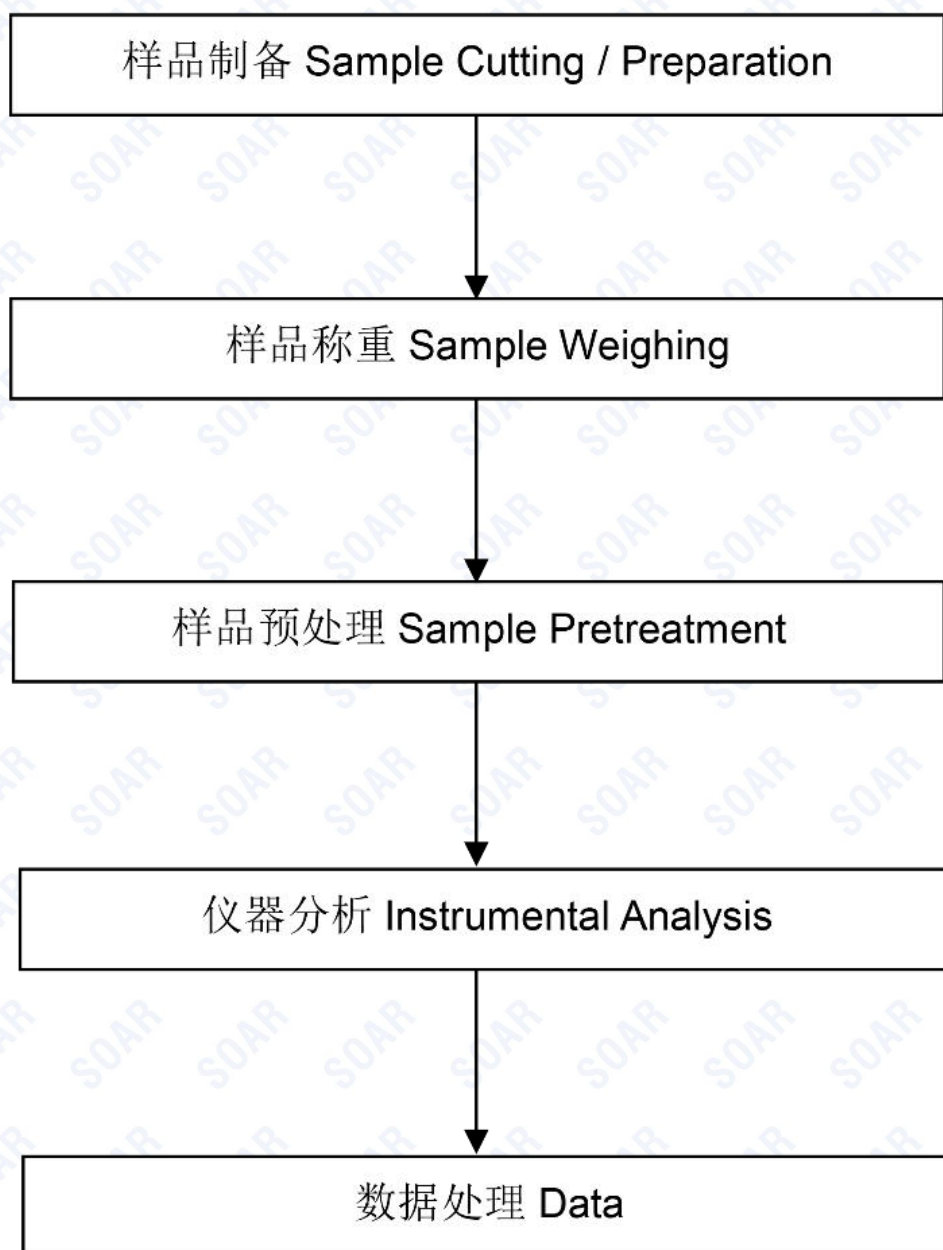

REACH 检测流程图

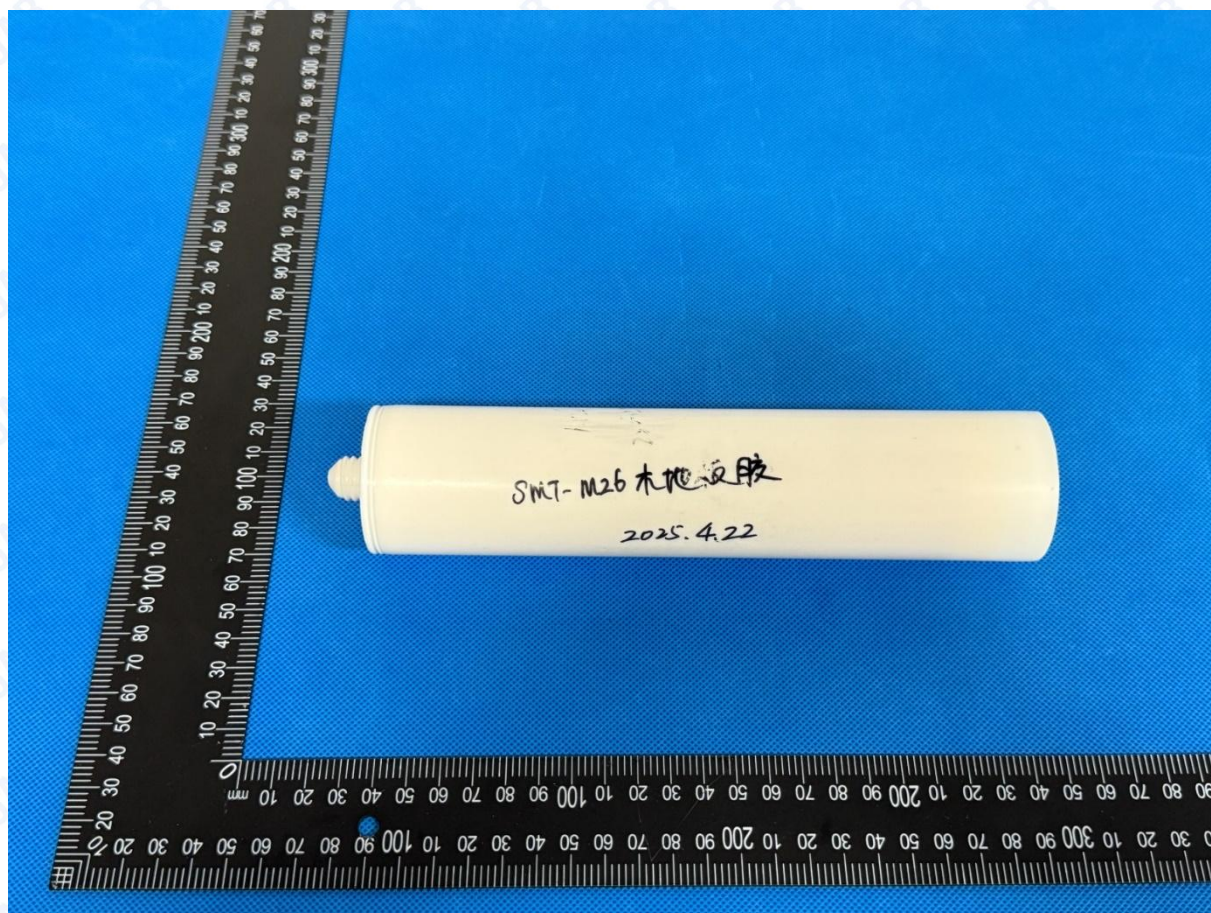
